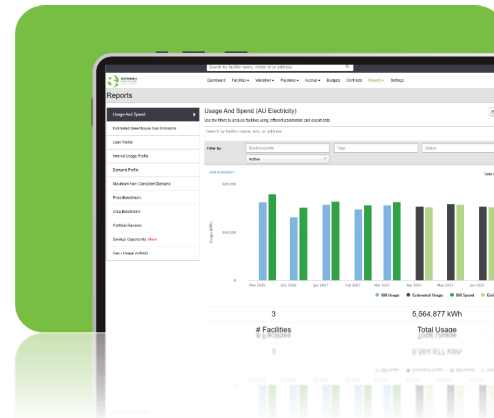

Automation powered by robotics

Bill Clarity utilises full Robotic Process Automation which is capable of processing thousands of utility bills per minute. The cloud-based platform simplifies the complex utility spend management process for medium to large businesses by automating manual processes and providing complete control over their full bill cycle.

The platform:

- Automatically captures and validates invoices
- Automates the accounts payable function
- Provides clients with opportunities to reduce costs

BILL VALIDATION

A number of complex validation checks are carried out on all new bills as they are automatically uploaded into the SES Portal which ensures all data is expertly validated, resulting in 99% accuracy and integrity.

Having data that you can trust, gives you confidence that you are only paying for what you are contracted to pay. The additional insights you can access are real opportunities that can then be actioned to create value for your portfolio.

Automated validation checks include:

Bill Receipt Checks: Late arriving bills alert, supplier notification and estimate missing bill value for accruals.

Bill Integrity Checks: Duplicate or over-lapping bills and bills on closed sites. Late fees alert and optimise payment process: Missing charges on bills, estimate, accrue and pay bills on time. Track incorrect bills and recover over-charges.

Bill Tolerance Checks: Total usage within Customer set tolerance of previous bills and quarantined if extreme as well as total spend within customer set tolerance of previous bills.

Bill Matching Checks: Usage matches interval data; prices match the contract, utility charges match utility tariff assigned, demand charges match utility tariff assigned, environmental compliance charges, state/federal mandated charges (taxes, levies, etc.).

Payment File Checks: No duplicate entries, all accounts on active site list, total within tolerance, all payment values within a relevant date range.

Budgeting and accruals

Bill Clarity calculates accruals at portfolio level and account level, in real-time, saving your business money by capturing billing errors which increases the reliability of the utility spend forecasts and the ability to instantly access accurate historical billing data. You will also be able to create and modify budgets in minutes.

The platform calculates and presents the following accrual functionality for all active accounts:

- Aged accruals
- Current accruals
- Accruals are presented at the account level and portfolio level
- Calculation of liabilities based on a combination of historical bill observed, recent meter data, and known commodity and other charges.
- Bill Clarity is a SaaS solution securely hosted on the Amazon Web Services cloud enabling your team to access your utility history anywhere, anytime.
